New Delhi, July 11

The Department of Telecom has banned the use of "non-trusted telecom gear" for expansion of communications networks.

According to the amended rules for telecom licences issued on Monday, the DoT has added the word "expansion" to plug a gap in previous rules that were issued to restrict the use of non-trusted telecom gear in the telecom networks.

"With effect from June 15, 2021, the licensee shall only connect trusted products in its network and also seek per-
