Textual Information()

The equity shares held by the shareholders as on September 25, 2023, being record date for the purpose of extinguishment of capital, has been extinguished in the manner set out in the Resolution Plan approved by the Honble National Company Law Tribunal (NCLT). Accordingly, 59,38,100 equity shares held by 1,434 shareholders were allotted 1,434 equity shares of Rs.10 each.

Further allotment of 41,50,000 Equity Shares made to Equator Financial Services Limited pursuant to the Resolution Plan approved by Hon'ble National Company Law Tribunal vide its order dated 21st March, 2023 and Equator Financial Services Limited is classified as Promoters.

The Application for Listing of Equity Shares is submitted to the BSE Limited and further the Company will take suitable actions to comply with the minimum public shareholding as required under law for which an undertaking is also submitted by the new Promoters with Listing Application.
